### Application deadlines

You can apply for parental benefits for fathers after your child has been born or identified for adoption.

**Paternity allowance:** no later than 2 months after the child has reached the age of 2 years.

**Paternity allowance for adoptive parents:** no later than 2 months after the date on which 2 years have passed since the date of placement.

**Parental allowance and partial parental allowance:** no later than 1 month before the date on which payment is set to begin.

**Parental allowance for adoptive parents and adoption grant:** within 2 months of the date of placement.

**Child benefit:** within 6 calendar months. You can use this application to claim child benefit, but a decision on the child benefit will not be given until your child has been born.

#### Paternity allowance after the parental allowance period

- i** You can receive paternity allowance for 54 working days in up to 2 periods after the parental allowance period. If you received paternity allowance during the maternity and parental allowance period, the remaining number of days for which you can receive paternity allowance is equal to 54 days minus the number of days you have already used.

Although the right to day care placement is retained, the child may not actually be placed in day care during the paternity allowance period. The eligibility for the paternity allowance must be used before the date when the child reaches the age of two or before two years have passed since the child was adopted.

If the parental allowance period starts 1 April 2019 or later and more than one child is born to your family at the same time or more than one child is adopted at the same time, you are entitled to an extended paternity allowance period. The extension of the paternity allowance period can be used during the maternity allowance or parental allowance period or after the parental allowance period.
